



Privacy Policy

Policy regarding the processing of personal data

Key points

1.1. This Privacy Policy (terms) (hereinafter referred to as the Terms) governs the legal relationship between the User (Customer) and the Operator.

1.2. The User must be fully acquainted with these Terms before using a feature of the Website.

1.3. In case of disagreement with the terms of the listed Terms, the User is obliged to refrain from further use of the Site.

1.4. These conditions are valid only on the territory of the Republic of Armenia

2. Terms and definitions

2.1. In these Terms, unless the context otherwise indicates, the following capital letters have the following meanings:

2.1.1. "Operator" - a citizen of the Republic of Armenia, for example.

2.1.2. "Personal data" - personal data provided by the User about himself. name (including alias); delivery addresses; telephone number; Email the address).

2.1.3. "User" (Customer) - a visitor who already has a personal account.

2.1.4. "Products" – Products

2.1.5. "Site" - <https://nerosushi.am/>

2.2. For the purposes of these Terms, unique terms and definitions apply to multiple terms—definitions—and vice versa.

3. Conditions for the processing of personal data of users

3.1. The Operator does not verify the accuracy of personal data provided by Users. However, the Operator assumes that the User provides reliable - sufficient personal information - updates this information.

3.2. The processing of personal data within the framework of these Terms means the



collection, systematization, storage, storage and destruction of personal data.

3.3. Purposes of personal data processing.

3.3.1 Order processing;

3.3.2 Evaluation of the quality of service.

3.3.3 Consumer (client) accounting.

3.4. The User acknowledges that his consent to the Terms (field "I agree to the processing of personal data under the terms of the User Agreement") means your full agreement with the User in all its conditions without exception.

3.5. The User has the right to change

3.6. The user agreement for the processing of his personal data is valid from the moment it is received by the Operator in accordance with clause

3.7. From the conditions to the date of withdrawal of the contract by sending a written request to the Operator.

3.8. The Operator has the right to transfer the User's Personal Data to third parties in the following cases: 3.7.1. For the user's use of the site.

3.8.1. Provide services to the user;

3.9. The operator directly processes personal data.

3.10. The Operator protects the Personal Data of Users, ensuring their confidentiality and protection from unauthorized or accidental access by third parties.

3.11. The Operator undertakes to prevent unauthorized access to the Personal Data of Users provided to the Operator. timely detect and stop such attempts.

3.12. The Operator has the right to block, exclude, delete information posted by the User, without the consent of the latter, if such information does not comply with the current legislation of the Republic of Armenia and the provisions of these Terms.

4. "Cookie technologies used by the Operator on the Site



4.1. The Operator has the right to use "Cookie technology" to store information about the ip address of Visitors and Users of the Site. "Cookies are not used to store confidential information about Visitors and Site Users and are not intended to identify the Visitor and Site Users. All collected and analyzed information is anonymous.

4.2. "The use of cookie technology is the placement on the Site of certain characters (characters) that are stored on the computer (hereinafter referred to as the "device from which the site was logged in"). access to certain sections of the Site.

4.3. The purpose of the use of cookie technology by the operator.

4.3.1. Analytical activity to study the preferences of visitors and users of the site.

4.3.2. Statistics of visitors and user activity on the site.

4.3.3. Improving the performance and efficiency of the site;

4.3.4. Website analysis and error correction, Improving the performance of all site resources.

4.3.5. Security and integrity of site resources.

4.3.6. displaying advertisements for our services on third party websites.
